End-User License Agreement

Update January 18, 2023

This End-User License Agreement (“EULA”) is a legal agreement between you (either as an individual or on behalf of an entity) and Mustang Pro. Mustang Pro is a brand of Mustang Tech LTD – a private limited company incorporated in the United Kingdom, under license number LTD-14364568, and having its address at 128 City Road, London, United Kingdom, regarding your use of the software (“Software”).

Introduction

For the proper and legal use of the Software, you must agree to all the terms set out in this EULA.
